SITUATIONAL AWARENESS

- Dr. Mike Ryan, executive director of World Health Organization (WHO) Health Emergencies Programme, said "We need to be cognizant of the fact that the disease can jump up at any time. We cannot make assumptions that just because the disease is on the way down now that it's going to keep going down, and the way to get a number of months to get ready for a second wave – we may get a second peak in this way."
- Governor Whitmer signed Executive Order [2020-104](#), which expands the types of medical personnel that can order a test, and creates a new category of community testing sites that offer testing to anyone with reason to be tested without an advance order, and without charging an out-of-pocket cost to any Michigander.
- MDHHS announced it is greatly expanding testing criteria for COVID-19 to provide access to additional residents who do not have symptoms but are at risk. The new criteria includes asymptomatic patients who are preparing for surgery if testing is deemed necessary by the treating health professional. It also includes asymptomatic people who have known exposure to someone who has COVID-19 or symptoms, or who work in a profession that puts them at high risk of exposure due to close contact with the public.
- A new, [online dashboard](#) launched that visually illustrates COVID-19 risks and trends in Michigan, providing residents with important information about the pandemic status where they live and work.
- The Michigan Department of Health and Human Services (MDHHS) changed the way it reports data on COVID-19 testing. The change makes the data more accurate and relevant as the state continues to expand diagnostic testing to help slow and contain the spread of COVID-19. The update to the website separates out the results of two different types of tests – serology and diagnostic.
- One hundred-forty clients at a hair salon in Missouri may have been exposed to COVID-19 after a second hairstylist at the location tested positive for COVID-19. The city of Springfield said 91 people had been exposed after a stylist worked for eight (8) days while showing symptoms. Now, 56 more clients have been "potentially directly exposed," the city said, saying the second stylist at the Great Clips salon tested positive and worked for five days while "experiencing very mild symptoms."
